3	Resolution supporting a California Statewide producer responsibility program to
4	minimize marine plastic pollution and to help advance San Francisco Zero Waste
5	Goals.
6	WHEREAS, The health of San Francisco and California's waterways, public spaces,
7	coast and ocean is increasingly threatened by the persistent influx of plastic pollution that
8	harms the environment and economy; and,
9	WHEREAS, The vast majority of litter in California's coast and ocean comes from land
10	based sources, and it is well documented from more than 25 years of coastal cleanup data
11	that up to 90 percent of floating marine litter is plastic; and,
12	WHEREAS, A 2012 study by the Convention on Biological Diversity found that 663
13	marine species have been impacted by marine litter through entanglement and ingestion—a
14	two-thirds increase in impacted species from a similar study in 1998; and,
15	WHEREAS, Research by the Algalita Marine Research Foundation shows that
16	persistent organic pollutants in the marine environment attach to the surface of plastic debris
17	and floating plastics have been found to accumulate pollutants and transport them through
18	ocean currents, and marine life that ingests plastics coated with pollutants absorb these
19	pollutants, and,
20	WHEREAS, In 2012, the US Environmental Protection Agency Region 9 estimated
21	west coast cities and counties spend approximately \$520 million each and every year to
22	combat litter and curtail marine debris; and,
23	WHEREAS, The global production and consumption of plastic—especially single use
24	plastic products—is on the rise; and,

1	WHEREAS, Existing federal and state laws designed to combat marine litter are failing
2	to keep plastic pollution from entering the ocean and harming marine wildlife and coastal
3	economies; and,
4	WHEREAS, Of the many plastic materials that pollute the ocean, single-use plastic
5	items are some of the worst offenders, for example, a bay area litter audit in 2010-2011 found
6	that 2/3rds of the litter entering the bay was single-use food and beverage packaging.; and
7	WHEREAS, A new approach is needed in California to reduce the impacts of single-use
8	plastic products on San Francisco and California's environment and economy; and
9	WHEREAS, The San Francisco Department of Environment is committed to the tenets of
10	producer responsibility as essential to reaching San Francisco's Zero Waste goals; now,
11	therefore be it,
12	RESOLVED, That the San Francisco Commission on the Environment strongly
13	supports statewide legislation to create a Marine Plastic Pollution Producer Responsibility
14	Program ("Program"); and, be it,
15	FURTHER RESOLVED, That the San Francisco Commission on the Environment
16	urges the State Legislative Committee to urge the California Legislature to pass statewide
17	legislation to develop the Program to include specific, aggressive, and enforceable marine
18	plastic pollution reduction and landfill reduction goals, targets and compliance dates; and, be
19	it,
20	FURTHER RESOLVED, That the Commission urges the State Legislative Committee
21	to urge the California Legislature to pass statewide legislation to develop the Program to

e Committee to urge the California Legislature to pass statewide legislation to develop the Program to effectively define and cover the items most commonly found as pollution, particularly plastic packaging; and be it,

FURTHER RESOLVED, That the Commission urges the State Legislative Committee to urge the California Legislature to pass statewide legislation to develop the Program to shift

2	packaging at the end of its useful life to producers of the products, thereby substantially	
3	reducing financial burden for implementation of marine plastic pollution prevention	
4	infrastructure and activities on local governments, taxpayers, and regional water districts, and	
5	supporting California's economy; and be it,	
6	FURTHER RESOLVED, That the Commission urges the Program to include provision	
7	for ongoing monitoring to show impacts of the Program such as the measurable reduction of	
8	plastic pollution in the marine environment and to better understand the sources, pathways,	
9	and impacts of marine plastic pollution; and be it,	
10	FURTHER RESOLVED, That the Commission urges the State Legislative Committee	
11	to urge the California Legislature to pass statewide legislation to develop a Program that does	3
12	not preempt state or local plastic bag laws, the California Beverage Container Recycling and	
13	Litter Reduction Act, or other demonstrably effective laws related to reduction or recycling of	
14	the most prevalent items found in marine plastic pollution; and be it,	
15	FURTHER RESOLVED, That the Commission urges the State Legislative Committee	
16	to urge the California Legislature to pass statewide legislation to develop a Program that does	3
17	not permit use of high temperature material destruction technologies (often called "waste-to-	
18	energy" or "conversion technology") activities in achieving stated goals.
